**Position:** Political-Military Analyst/Director of Air Operations - FSN-9, FP-5\*

**Open to:** All interested Candidates

**NOTE: ALL APPLICANTS MUST HAVE THE REQUIRED RESIDENCY PERMITS (TEMPORARY OR PERMANENT) TO BE ELIGIBLE FOR CONSIDERATION. NON-RESIDENT APPLICANTS MUST PROVIDE DOCUMENTATION WITH THEIR APPLICATION THAT DEMONSTRATE THAT THEY HAVE THE RIGHT TO LEGALLY LIVE AND WORK IN THE RUSSIAN FEDERATION.**

The U.S. Embassy in Moscow is seeking an individual for the position of Pol-Mil Analyst/Director of Air Operations in the Defense Attaché Office.

### BASIC FUNCTION OF THE POSITION

The position plans and coordinates participation by the United States elements in bilateral US-Russia Workplan activities dealing with air and/or space. Manages preparations for and oversees execution of these in Russia and administratively facilitates Russian participation in these events when they occur abroad. As political-military analyst, reviews open-source publications and online information on a daily basis to provide political-military analysis to the Defense/Air Attaché on a variety of topics along with analysis/recommendations on means to enhance cooperative engagement. Manages the DAO's aircraft clearances program covering aircraft of all U.S. Government agencies: receives/launches U.S. aircraft, delegations, and aircrew upon arrival/departure to/from RF; facilitates customs and all forms of servicing; regularly acts as sole DAO representative for USG aircraft operations outside Moscow.

### QUALIFICATIONS REQUIRED

**All applicants must address each selection criterion detailed below with specific and comprehensive information supporting each item – this is in addition to the sending of a CV/Resume.**

1. University degree in international relations, business management, finance, or comparable, is required.
2. 2 years previous administrative, financial, or comparable experience with DOD, DOS, or other embassy office is required.
3. Level IV (fluent knowledge) English is required. Will be tested. Level IV (fluent) Russian is required.
4. Good knowledge of DOD and DOS finance and travel rules and regulations is required. Highly detailed understanding of flight clearance procedures is required. Highly detailed knowledge of host-country governmental structures, coordination procedures, and administrative requirements is required.
5. Must have very strong ability to manage projects from concept to completion, incorporating planning and execution relating to coordination, resources, facilities, logistical support, and financial management. Must be proficient in Microsoft Word, Excel, Access, and Power Point.

### SELECTION PROCESS

When equally qualified, Appointment Eligible Family Members and those with U.S. Veterans preference will be given hiring priority consideration. Therefore, it is essential that all candidates **address the required qualifications** above in the application.

### ADDITIONAL SELECTION CRITERIA

1. Management will consider nepotism/conflict of interest, budget and visa status in determining successful candidacy
2. Current employees serving a probationary period are not eligible to apply.
3. Must be able to obtain and hold a security clearance.
4. Currently employed US Citizen EFMs, who hold a FMA appointment, and currently employed NORs hired under a Personal Services Agreement (PSA) are ineligible to apply for advertised positions within

the first 90 calendar days of their employment, unless currently hired into a position with a When Actually Employed (WAE) work schedule.

5. AEFMs and FM/MOHs on the travel orders of a Foreign Service, Civil Service, or Military Officer permanently assigned to post and under Chief of Mission authority are not required to obtain work permits or visas for employment within a U.S. Foreign Service post in Russia.
6. Under the Russian law on citizenship, dual citizenship is not recognized by the Government of Russia (GOR) unless a bilateral agreement exists; one does not exist between the GOR and the USG. (Bilateral agreements on dual nationality do exist between Russia and Tajikistan) Employees and/or Appointment Eligible Family Members (AEFMs) who may have dual citizenship should advise the Human Resources Office before applying for any jobs at the Embassy or at the Consulates General.

**- To be considered for a certain position all interested candidates should proceed as follows:**

- A. Indicate the position you are applying for.
- B. Submit the following documents in English. For positions required level II (limited) English proficiency resume may be submitted in English or Russian:
  - Application for Federal Employment (SF-171 or OF-612); or
  - A current resume that addresses the qualifications for skills and abilities. In order to be considered, applicants must address each and every one of the required qualifications in this announcement and may submit a narrative statement on separate page with specific responses to each qualification.
  - Candidates who claim U.S. Veterans preference must provide a copy of their Form DD-214 with their application.
  - Documentation (essays, certificates, awards, copies of degrees earned) that addresses the qualification requirements of the position as listed above.

#### **DEFINITIONS**

1. AEFM: A type of EFM that is eligible for direct hire employment on either a Family Member Appointment (FMA) or Temporary Appointment (TEMP) provided s/he meets all of the following criteria:
  - US citizen;
  - Spouse or dependent who is at least age 18;
  - Listed on the travel orders of a Foreign or Civil Service or uniformed service member permanently assigned to or stationed at a US Foreign Service post or establishment abroad with a USG agency that is under COM authority;
  - Is resident at the sponsoring employee's or uniform service member's post of assignment abroad, approved safehaven abroad, or alternate safehaven abroad; and
  - Does not receive a USG annuity or pension based on a career in the US Civil, Foreign, or uniform services.
2. EFM: Family Members at least age 18 listed on the travel orders of a Foreign of Civil Service or uniformed service member permanently assigned to or stationed to a US Foreign Service post or establishment abroad with a USG agency that is under COM authority who do not meet the definition of AEFM above.
3. Member of Household: A MOH is a person who: 1) Has accompanied, but is not/not on the travel orders of a U.S. citizen Foreign or Civil Service employee or uniform service member permanently assigned to or stationed at a U.S. Foreign service post or establishment abroad; 2) Has been declared by the sponsoring employee to the Chief of Mission as part of his/her household; and 3) Resides at post with the sponsoring employee.
4. Ordinarily Resident (OR): A citizen of the host country or a citizen of another country who has shifted the main residency focus to the host country and has the required work and/or residency permits for employment in country.
5. Not-Ordinarily Resident (NOR): Typically NORs are US Citizen EFMs and EFMs of FS, GS, and uniformed service members who are eligible for employment under an American USG pay plan, on the travel orders and under Chief of Mission authority, or other personnel having diplomatic privileges and immunities.
